

Session Report

In 2017, the Session welcomed our new pastoral leadership, the Reverends Bruce and Carolyn Gillette, and said farewell to the Rev. Dr. Drew Mann, our interim pastor and moderator since the fall of 2015.

There were three congregational meetings called by the Session in 2017: the 128th Annual Meeting on February 12, a special meeting of the congregation held March 12, for the purpose of receiving the report of the Pastoral Nominating Committee, at which the congregation voted to elect the Reverends Bruce and Carolyn Gillette as co-pastors; and a special meeting of the congregation on December 10, for the purpose of receiving the report of the Representative Nominating Committee, chaired this year by ruling elder Sean Whalen, and electing ruling elders/trustees, deacons, and members at large of the 2018 Representative Nominating Committee.

In January, the Session welcomed returning ruling elders Jeffrey Bowker, Raelyn Harman and Kate Shackelford and incoming ruling elders Deborah Rottinger and Eileen Wiggins, both returning to the Session after previous service. During 2017, the Session held twelve stated meetings, continuing to meet during the summer months because of the press of business. There was one special meeting, to receive new members and discuss the results of an environmental inspection report.

At its last stated meeting of 2017, thanks were expressed to the following ruling elders who had completed their terms and were ineligible for re-election or did not wish to serve a second term: Ronald Homer and Jason Sheau. At the December 10 congregational meeting, ruling elders Rachel Carnahan, Will Schick and Karen Wong were re-elected to second three-year terms and Kevin Davis and Becky Lazo were elected to three-year terms.

Church membership at the beginning of 2017 was 403, and we finished the year with 405 members, for a net increase of two. We received 11 new members by transfer or reaffirmation of faith. Three members transferred to other churches, and there were six deaths, for a loss of nine members. The Roll of Baptized Members went from 102 to 97, with seven baptisms of children and 12 removals.

The annual review and examination of the Church Register for the year 2016 took place on September 16, 2016 at the Church on the Mall. The records were approved with one exception, because an audit planned for 2016 did not take place.

In the unicameral system used at Overbrook and in many other Presbyterian churches, the Session is also the Board of Trustees, and all ruling elders also serve as trustees, dealing with matters such as property in addition to issues related to the mission of the church, such as worship and music, stewardship, mission and outreach, personnel and Christian education. These varied functions are reflected in the committees of the Session, whose reports appear on the following pages.

Pastors' Report

Report of the Pastors for 2017 Bruce and Carolyn Gillette

With great joy we began our work as your pastors on April 24, 2017. As we reflect on our first eight months of ministry here in this wonderful congregation, we are reminded of some of the words of the hymn, "Called as Partners in Christ's Service," written by Jane Parker Huber (a hymn writer who also wrote OPC's Centennial Hymn):

***Called as partners in Christ's service, called to ministry of grace,
we respond with deep commitment, fresh new lines of faith to trace.***
(verse 1, lines 1 and 2)

Called as Partners: We are very thankful that we received a call to OPC to serve as your pastors— as partners in Christ's service with you. Thank you for the ways you have welcomed us into this congregation and for a joyful installation service and reception on May 28. Thank you for welcoming us into many of your homes for small group "Get to Know the Pastors" meetings, with food, conversation, and new friendships. Thank you for the many ways, large and small, that you have helped us to feel welcome here. We are grateful for your commitment to Jesus Christ, your commitment to his church, and your willingness to welcome us as your new pastors.

***Men and women, richer, poorer, all God's people, young and old,
blending human skills together gracious gifts from God unfold.*** (verse 2, lines 3 and 4)

All God's People: Overbrook Church is known for its wonderful diversity that brings people from different socio-economic and racial-ethnic groups together. OPC also has a delightful diversity in terms of people's ages, interests, hobbies, work, life experiences, and denominational backgrounds. We experienced the richness of this diversity at A Taste of Overbrook in the Fall. We have also seen it as many of you have shared your vision of what the church should be. We have enjoyed getting to know some of you at the Bible studies we have taught, and at last Fall's Parenting Class. We enjoyed your commitment to justice and love as you shared your many, varied gifts on the Martin Luther King Day of Service at the beginning of 2018. Some of you grew up at Overbrook Church; others have come from other denominations and congregations, bringing your own expectations and vision. God's call is for us to blend together our skills, and our understandings of "church" so that God can use our gifts together for the good of all. This year, as we listened to and learned from one another, God was at work in this church.

***Thus new patterns for Christ's mission, in a small or global sense,
help us bear each other's burdens, breaking down each wall or fence.*** (verse 3, lines 1 and 2)

New Patterns for Christ's Mission: We are reminded of this part of Jane Parker Huber's hymn for a couple of reasons. First, it talks about newness— new patterns of Christ's mission. As we have been in conversation with many of you we have been reminded how much newness there is here and now. OPC has experienced tremendous change in the past few years— with new pastoral leadership, new Christian Education leadership, a new music director, an office manager who has been at OPC for just a year and a half, and a new financial secretary. More than one person has remarked that Leonard Robbins, OPC's custodian, is the longest serving staff member! We are grateful for staff members who served faithfully for many years, and for those, like us, who are just beginning their service. Thanks to paid staff members,

Dr. Christopher Gage, Lisa Faso, Carol Rozmiarek, and Leonard Robbins, and to elders, deacons, and all church members who have worked faithfully and lovingly during a time of great change.

Help us bear each other's burdens: We all need to acknowledge the grief and anxiety that comes with so much change in a church in such a short amount of time. People ask the question: "Will this church be the same as it always has been, for me and my family?" There is grief as the inevitable changes happen. Even if many programs remain the same, new staff members bring new personalities and new ideas. As your pastors, we have sought to listen to your concerns, your grief, your hopes and your dreams. We have asked a lot of questions of many people in leadership and in the pews, in order to continue many of the wonderful traditions at OPC. In planning Vacation Bible School, the Youth Mission Trip, Adult Forum, weekly worship services, the Messiah Sing, the Christmas Eve Family Service, the Service of Lessons and Carols, and many other things, we have sought to celebrate the best of OPC traditions. A strong emphasis for us has been visiting many of you in homes, hospitals and nursing homes— and working with the Deacons and others—to provide loving pastoral care to "bear one another's burdens," because we love and care for all of you.

***Words of comfort, words of vision, words of challenge said with care,
Bring new power and strength for action, make us colleagues, free and fair.***
(verse 3, lines 3 and 4)

Words: Communication is the key to breaking down each wall or fence. There have been times when people at OPC have had different understandings of the church's ministry; there are challenges in every growing relationship. In each worship bulletin, and in each church newsletter and pastoral note, there is an invitation to come and talk with us. We are grateful to the many OPC members and friends who have shared joys, concerns, new ideas and affirmations. In any family, including in our church family, we grow closer to each other when we listen to each other and spend time together. We invite you to give us a call or drop us a note and suggest a time you would like to get together— maybe for a meal or simply for a conversation at the church office. We look forward to this New Year and to getting to know each one of you better, as we continue to celebrate the best of what OPC has been, and as we move forward together.

So God grant us for tomorrow... (verse 4, line 1)

Tomorrow: Our faith in God gives us all hope, as a church. As your pastors, we look forward to the new year of serving with you. When we all look at God's church and at the world around us, we see both joys and challenges that lie ahead. We are grateful for new and developing friendships at OPC, and we look forward to serving with you in 2018 and beyond. We pray that God will "make us partners" (verse 4, line 3) in ministry together. We are excited and humbled by the possibilities that lie ahead, as we serve together with you in love.

Director of Music's Report

2017 was a year of change and growth for the music program at Overbrook Presbyterian Church. On Sunday, July 30, Dennis Elwell was honored for his forty-four years of service to this church's music ministry, and the tenure of the new Director of Music began on Monday, August 28.

The Overbrook Choir and Quartet provided anthems, solos, and musical leadership throughout the year: the full choir sang for most worship services except during June, July, and August, when our soloists sang in worship. We continue to express our gratitude for the members of the Overbrook Quartet: Iris Fairfax, Lois Randel, Toffer Mihalka, and Matthew Lulofs.

On Sunday, October 29, a hymn festival was held to celebrate five hundred years of the Protestant Reformation; robust attendance allowed us to make a sizable contribution to the food ministry at Calvin Presbyterian Church. The Choir and Quartet were joined by violinist Johnny May and cellist Elizabeth Mendoza. The Messiah Sing, which was held on Sunday, December 3, was another successful event with over 230 people in attendance; Paul Fleckenstein once again accompanied the soloists and congregation.

The Overbrook Junior Choir, accompanied by Victor Fiorillo, and the Overbrook Westminster Handbell Choir each performed approximately once per month, including the 4:00 p.m. service on Christmas Eve.

The Director of Music appreciates the warm welcome given by the congregation of Overbrook Presbyterian Church and looks forward to another wonderful year of music-making.

The committee welcomed Bruce and Carolyn Gillette, our co-pastors, on April 24; their first worship service was on April 30. Chris Gage began as our new music director on August 28 with his first service on September 3. The committee met throughout the summer to continue getting to know each other and working to provide meaningful worship for the congregation.

We accepted with regret and thanks the resignation of Calvin Marshall from the committee. We welcomed Eileen Wiggins who serves as scrivener.

The committee participated in the farewell activities for Interim Pastor Drew Mann, and the many tributes and farewells for Dennis Elwell as he retired after 44 years of service as Minister of Music at the end of July.

This was a year of change, as we adjusted to having two pastors on the dais every Sunday. Lay leaders have adjusted well. Additional prayer was added before the Scripture readings, and other minor changes were made in the role of the lay leader.

The *Gloria Patri* was reinstated as the response to the Assurance of Pardon. This is the traditional response sung in Presbyterian churches. The bulletin was changed back to the previous format; no complaints were received.

Two new sets of Paraments were obtained. The White arrived in time for Easter, and the Green, which are used much of the year, arrived in early summer. The lovely Blue hand-crafted paraments were enjoyed during Advent.

Nickie Stokes continues to supervise Communion and the Acolytes. Alyce Marsh continues to recruit Lay Leaders. Dick Williamson continues to work with the ushers. Laurie Geers joined the ushers this year. Volunteers are always welcome for any of these ministries.

Chris Gage arranged and held a concert to celebrate 500 years of the Reformation, during which we were able to hear his wonderful skill as an organist. A Thanksgiving Service was held on Tuesday, November 21, with the choir participating.

In December, the Service of the Longest Night was held for those grieving or otherwise unhappy during the Christmas season. It was well received and attendance was better than in past years. The annual *Messiah* sing was well attended and appreciated by the larger community.

Through all our transitions, weekly attendance has held steady at an average of 142.

We look forward to another year of working toward satisfying and meaningful worship through music and the Word.

Christian Education Committee

The mission of the Christian Education Committee is to assure educational ministry is accessible, inviting and relevant to the needs of the Overbrook Church family, and most especially, true to God's Word. Throughout 2017, the CE Committee, with the support and inspiration of the congregation, worked to fulfill this mission. As students and teachers of faith, and celebrants of lifelong Christian learning, we continue to provide and give thanks for the following opportunities:

Sunday School: Throughout the school year, Bible-based instruction is provided for children in preschool through sixth grade. Grades 9-12 met after listening to the sermon for a time of Bible-based discussion on topics related to service and personal spiritual growth. In 2017, we resumed collecting offerings during Sunday School to be sent to St. Vincent School for the Handicapped as voted by the kids.

Children and Youth in Worship: The children and youth of OPC continued to learn by serving in worship leadership. In September 2017 middle and high school students led worship and shared inspirational accounts of their experiences during the youth mission trip to City Service Mission in Philadelphia.

Vacation Bible School: The Bible-based, summer learning program is designed for our pre-K through fifth grade students. In 2017 our theme was *Clean Water for All God's Children*, where the students heard Bible stories about water and participated in hands-on experiments and fun with water. We had about 30 students participate in VBS.

Confirmation Class: there are eight students exploring their faith in the confirmation class which finishes up in the spring of 2018. With the help of a personal mentor, they will complete a personal Statement of Faith. The Confirmation Class meets prior to worship with Rev. Carolyn Gillette and participates in the entire worship service.

OPC Youth: Service learning and Christian fellowship programs support the faith formation of our middle and high school students. In the Fall of 2017, Rev. Carolyn Gillette alternated between the Junior High and Senior High Groups each week to meet for fellowship, mission and service. 11 OPC Youth participated on the summer mission trip in Philadelphia under the direction of CSM with the help of 3 chaperones.

Adult Education: Sunday Adult Forum continued to meet at 9:15 am in the Chapel, with shared learning and shared faith serving as a foundation for discussion. **Bible Study** was offered on Wednesdays and offered an exciting and informative examination of the scriptures which drew a diverse group of participants. In the Fall of 2017, two additional Bible Studies were offered on Sunday Morning and Monday Evenings where participants studied *The Bible from Scratch – New Testament*, for 8 weeks which was an introductory course into the Bible. Another offering provided was a 6 week – 2 hr Parenting Course focusing on children 5-12.

Cross-Generational Ministry: In 2017, the Christian Education Committee continued to sponsor several Prayer Breakfasts which offered opportunities for members and friends to gather around the OPC breakfast table in prayer and fellowship. The free-will offering supported aspects of the Christian Education program like the Youth Mission Trip or other ministries of the Church.

This past year, after returning in December 2016 under a restructured interim DCE position, Sharon Parker resigned in April 2017 with the hiring of the Reverends Bruce and Carolyn Gillette. Under their shared duties as new Pastors, they assumed the role and responsibility of the DCE and direction of the Christian Education programs. This year, under the recommendation of Rev. Carolyn Gillette, the CE Committee started the distribution of "Splash!" by Augsburg Fortress to children baptized at OPC. This curriculum is for infants to the age of 3 and their parents providing them with readings, music and stories to connect families with young kids, celebrate milestones and events, and help develop their faith.

In 2015, PA Act 153 went into effect which mandated all volunteers working with the children under 18 to get background checks clearances and mandatory reporters training. This requirement limited the number of adults to teach Sunday school, chaperone youth events and other events working with the children. Looking forward to 2018, we hope more parents and adults would take to time to get the required clearances and training so we can expand our pool of resources and events for the children of the church.

Mission & Outreach Committee

2017 was an extraordinary year for Overbrook Presbyterian Church Mission and Outreach Committee. The M & O committee's mission and service work is rooted in compassion, love and to serve one another. Our chief criterion is that our giving should reflect the words and example of our Lord Jesus Christ, particularly his emphasis on caring for "the least of these" – those who are most in need.

Feed My Starving Children was a new program this year. FMSC is a Christian non-profit that provides nutritionally complete meals for thousands of malnourished children in areas around the globe including the US. Organizations support FMSC by hosting "MobilePacks" to prepare and pack meals for shipment. We partnered with Monsignor Bonner & Archbishop Prendergast High School. On April 22, we brought together 459 volunteers and packed 104,976 meals and raised over \$24,000. Those meals were shipped to two destinations: 3,888 individual meals were sent to Sierra Leone feeding 10 children for a year. 101,088 meals were sent to the Dominican Republic to feed 276 children for one year! The 2018 MobilePack will be Saturday, April 28th. Leading the 2017 FMSC initiative at OPC were Janet Bowker, Nancy Gilhool, Becky Lazo, Deb Rottinger and Jim Vagnoni.

Broad Street Ministries is a social justice ministry that welcomes, serves, shelters, supports and befriends the poorest of our community regardless of faith commitments or lack thereof. BSM provides for basic subsistence needs of food, clothing and shelter as well as spiritual nurturing through creative worship to hundreds of homeless individuals. OPC provides volunteers and significant cash support to Broad Street Ministries to achieve its mission. Deb Rottinger serves as OPC liaison with BSM. She led the Family Soup Making effort for BSM January through March an effort particularly enjoyed by the children that participated. Last summer the Youth Mission Trip worked through BSM as our OPC youth helped people in need in Philadelphia. Gardeners can help tend the new vegetable gardens at Carousel House a new BSM initiative to help feed their guests.

The 2017 theme of **One Great Hour of Sharing**, "Overflowing Generosity", focused on the need for safe drinking water. The OPC congregation responded to the 2017 appeal with noteworthy generosity contributing \$3,737.00 to OGHS. Emily Amerman coordinated the 2017 collection.

The Women's Dining Circle, Church members nominate prospective recipients to attend a dinner at the home of an OPC member. Women who attend hear a presentation from the featured charity and respond with their personal donations. OPC through the Mission and Outreach budget then matches the amount donated. The programs supported in 2017 were: Dignity Housing, the OPC Youth Mission Trip, Paws and Affection and the Please Touch Museum.

The meal prepared for the **Delaware County Life Center** is another ongoing OPC effort that serves the least of our brothers and sisters. The Life Center is a ministry that serves destitute people in West Philadelphia and Delaware County. The Center is located at 63rd and Market Streets, on the border of West Philadelphia. Nancy Gilhool coordinates OPC members and other volunteers who plan, prepare and serve dinner to more than 150 people. Overbrook Presbyterian Church is responsible for the meal four times a year.

The Hunger Store is open monthly for OPC members to contribute to a food bank by purchasing specific food staples for people in need. Mike Rottinger runs The Hunger Store after Sunday Worship during Fellowship hour. The food is donated to the Food Cupboard at Calvin Church in West Philadelphia.

Heeding God's Call to Reduce Gun Violence is a grassroots organization that raises awareness of the lives lost to gun violence in Philadelphia. 2017 marked our second "Memorial to the Lost" and the first time we

combined it with the Martin Luther King, Jr. Day of Service. We were sad to include a t-shirt for Leonard Robbins' son, which received a special blessing. Jeff Bowker and Jane Rozmiarek led the project.

OPC has been helping **TheVillage** (formerly Presbyterian Children's Village) for decades and continued to do so in 2017. In addition to a generous donation, Nancy Gilhool led "The Book Bag Project - Back to School! TheVillage". OPC collected back packs, school supplies, and cash to make sure the children are ready for the first day of school. Twenty-six stuffed backpacks were delivered to the Village in August.

Christmas Giving 2017 consisted of OPC's two traditional efforts. The 2017 **Fair Trade Market**, led by Janet Bowker, Deb Rottinger and Jane Rozmiarek to provide a market for artisans who are paid a fair price for their work and allow consumers access to gifts from around the world. Over \$4,000 of goods were sold. The **Adopt a Family** project had another outstanding year. Thirty-three Overbrook families participated, contributing gifts for 16 children and parents, to make their Christmas brighter. Puzzles, books, clothing, remote-controlled cars, Star Wars toys, a punching bag, balls, games and two bicycles are only a partial list of what was generously given in the true spirit of Christmas. Emily Amerman and Jim Vagnoni managed this year's Adopt a Family.

Overseas Missions were a highlight. In April, a video conference with the Rev. Sirarit Pusurinkham, our contact at **Overbrook Hospital**, was held as an introduction to an OPC delegation visiting the hospital in Thailand, in February 2018. This summer, Barry and Shelly Dawson, two **PCUSA missionaries from Southeast Asia**, shared their mission work with photos and stories. They offered an overview of the challenges and joys experienced by Christians in South East Asia at the Adult Form, from the pulpit and during an evening of fellowship and learning highlighted by a delicious multi-cultural meal. To further encourage overseas missions, Jason Duckworth established a scholarship fund to honor his mother Sharon Parker. This fund is to be used to support mission work and requests for scholarships will be evaluated by a board that includes Christian Education and Mission & Outreach. Sharon Parker is off to Myanmar and Mission & Outreach presented her with a check to show our support for her mission.

A special appeal in September to help families victimized by Hurricane Harvey via a donation to the Presbyterian Disaster Assistance. In October, members of the congregation participated in the CROP Walk a unique and enriching experience to raise money to support disaster relief and refugee ministries. Overbrook Church joined members from Ardmore Presbyterian Church, Penn Wynne Presbyterian Church, and the Japanese Christian Church on the fundraising walk through the Wawa gardens in Middleton, PA.

Congregational Life Committee

The purpose of the Congregational Life Committee (CLC) is to develop a sense of community among the OPC community by planning, executing and/or providing support for church-wide events that in general are related to hospitality. The Congregational Life Committee is an amalgam of different OPC community activities loosely organized under the umbrella of a single committee. The size of the committee has grown to include: Artia Benjamin, Raelyn Harman (Chairperson), Sharon Parker, Latoya Richie, Aimerie Scherluebbe and Amarilis Stricker. Following is a list of activities that fall under this umbrella:

Christmas Eve Dinner*: Organized by Raelyn Harman and executed with the help of many church “elves”. Provide dinner to all present after the Christmas Eve Family Service. A free will offering was collected totaling \$306 which covered most of the expenses which were \$387 this year. The balance was paid by CLC budget.

Gingerbread Houses: In 2017, Artia Benjamin purchased 20 houses but recommends that 25 be on hand for the event in 2018. This is a very popular event that involves all ages.

College Student Luncheon Over winter break. Artia, Deja Stokes and Nickie Stokes were the point people for this event. This year the group met with the new pastors to get to know each other and exchange ideas. They expressed interest in going on an outing this summer together as a group of young adults.

Coffee Hour*: Organized by Amarilis Stricker, provided by volunteers who sign-up to prepare and serve it. Church openers start the coffee and hot water upon arrival on Sunday mornings. Any costs are paid for via the Congregational Life Committee budget. On several occasions when no one family or individuals signed up to host an ad hoc group contributed edibles and pitched in for set-up and clean-up or we’ve gone without it. In 2018, we would like to see the sign-up board have more than one line to help remind people they should be doing this with a group of people or more than one household. When no one signs up for a week the committee will take responsibility to insure there is a coffee hour. Bonnie Miller regularly makes generous donations to the stock of items served during coffee hour and faithfully serves tea every Sunday.

Game Nights: Organized by Jason Sheau. It is scheduled approximately 4 times per year. Participants contribute to the cost of take-out pizza and other miscellaneous expenses.

Narberth Community Theater Concession: Organized by Trudy Sheau and staffed by the volunteers she recruits. Pays for its own costs and surplus revenue contributes to OPC’s general fund. In 2017, it raised \$2611. Trudy is coordinating the purchase of disposable plates, plastic ware, napkins, etc. to save cost and to have them on hand for all who need these supplies.

Interim Pastor, Drew Mann’s farewell luncheon and collection for a gift was coordinated by CLC. Session members primarily underwrote the cost of the luncheon. A collection from the congregation was taken which covered the cost of two restaurant gift certificates and a framed collage of photos from OPC as a thank you gift for Drew.

An Appreciation Luncheon for Sharon Parker, Director of Christian Education was planned and executed by the CLC. \$2,000 was raised in donations from the congregation to fund something on Sharon’s “wish list” for CE. It appears the donations will cover the cost of purchasing some audio-visual equipment and make WIFI available on the 2nd floor in and near the room where the Youth Sunday School convenes.

* Additional coffee carafes were purchased for these events and for the use by all OPC fellowship events. Expenses related to hospitality can be paid for via the CLC budget.

Personnel Committee

Exit reviews were done for our past Interim Pastor, Drew Mann and our past Christian Education Chairperson, Sharon Parker.

Earlene Ford, our Financial Secretary, left in July. A new Financial Secretary, Carol Rozmiarek was hired in September.

The Music Director's job description was updated.

Work reviews were done for Lisa Faso, our Office Manager and Leonard Robbins our Custodian. They were excellent reviews.

Changes are still being adjusted in the office manager duties to facilitate the rental process. Office volunteers are still needed. We hope to work with a coordinator to help this process along.

The church staff has gone through many changes and challenges this past year. We welcomed Co-Pastors Bruce & Carolyn Gillette who started in April, and our new Music Director Chris Gage who started in August.

Our Code of Conduct is still posted on our website.

Stewardship Committee

We are blessed to have received 84 pledges for the 2018 church year totaling \$339,366. This compares to 99 pledges that added up to \$391,677 in total pledges for 2017. The 2017 Taste of Overbrook social/fundraiser raised \$5,260.37 for the church. Thanks to all those who cooked, who attended, who donated or bought auction items, and who helped organize this year. This was another wonderful event featuring the best of the church community--fellowship, food, and generosity.

We are blessed here at The Crossroads to have a very generous congregation with a warm and giving culture. Thanks go to the Stewardship Committee members who work hard every year on the pledge drive--Karen Wong, Kate Shackelford, Janet Bowker, Jason Sheau, Keedra Carroll, Davorka Sabljak, and Will Schick.

Thanks also to all our members and friends who contribute so we may continue building God's Kingdom here on Earth.

Finance Committee

Greetings:

This past year was marked by an investment in our leaders, ensuring the protection of our health and wellness, and securing our future. We remain blessed that our church family continues to grow both in numbers and in its commitment to support these investments:

- **Investment in our Leaders:** our leadership was significantly enhanced with the addition of our new co-pastors and our Director of Music. The respective search committees did phenomenal work in recruiting top talent and leaders for our congregation. The Finance committee responded to this opportunity by creating additional budget to demonstrate our commitment to our new leaders
- **Protection of our Health and Wellness:** this past summer we were made aware of both lead and asbestos related issues at the church. The Property committee expertly navigated us through the many complex issues related to assessing these problems, developing cost effective options to address them, and remediating them in an expedited manner. The Finance committee funded these needed remediation efforts without significantly impacting our operating budget. As a result, our members and our children remain in a safe environment to worship and gather
- **Securing our Future:** this year we truly saw the gratitude and commitment that our members have for OPC. We received a meaningful increase in our Endowment because of the foresight many of our members exhibited by including OPC in their estate plans. Each gift secures OPC's future. Each contribution also serves as a testament of the commitment our members to their faith and to OPC. We are extremely blessed by the generosity and the acts of faith that these members have shown

The Committee continues to vigorously monitor our budget and remains committed to maintain an operating budget that breaks even and does not need to be supported by withdrawals from our Endowment Fund. Given our investments and some extraordinary expenses this year, however, we were challenged to maintain budget neutrality. This year we generated a slight deficit of \$1,400. Fortunately, because of a surplus from last year, our members' commitment to their Stewardship pledges, and rental income we could absorb this deficit.

As noted, we were exceptionally blessed with gifts to our Endowment from the estate plans of our members. This influx of capital and a strong stock market has bolstered our Endowment Fund significantly. Our Endowment has increased by over 50% this past year and we have finally returned to over \$1 million in assets. It has been almost 10 years since we were at this level. We are very pleased with our progress, but as Haverford Trust, the manager of our Endowment reminds us, we need to target an Endowment of approximately \$2,000,000. We appreciate the continued consideration for including OPC in your estate plans.

Finally, the committee continues to be well supported by several committee members and staff. We are pleased to have Carol Rozmiarek assume the position of Financial Secretary. In a short period of time, Carol has made valuable contributions to the functioning of the committee. Kate Shackelford has been

serving as Treasurer and will be transitioning duties to Stephanie Morris in 2018, In addition, I will be transitioning the Chair role to Lainie Blodgett. The committee has been blessed to have Kate support us for so many years in so many ways. We owe Kate a debt of gratitude. Both Stephanie and Lainie have been quite active in the Finance committee for several years so we expect a seamless and successful transition. Other committee members include Sara Davis, Solomon Hunter, and Amos Paul.

In closing, OPC remains strong financially. Despite a small operating deficit, we funded needed expenses and invested and continue to secure our future. The Finance Committee remains encouraged that our congregation will continue to show its support for the Church at the Crossroads.

Property Committee

The Property Committee consists of four members of Session, and six members of the congregation at large. The Pastors serve on this committee ex officio. We are a very active committee, meeting on the first Wednesday of each month, except during the summer months, when we meet only as necessary.

The committee is responsible for handling building issues regarding use, cleaning, maintenance and improvement, which includes major concerns around heating and cooling systems, lighting, grounds maintenance and landscaping, building integrity (roof, walls and windows), security, and support of shared users (rentals).

In serving the Session and congregation in this way we count on the support of the Pastors, and other church staff. We could not function without the help of Lisa Faso and Leonard Robbins, whose service is invaluable.

We work with the Session and Finance Committee in developing a yearly budget which will be adequate to finance projects relating to all our areas of concern, and bring in additional revenue from rental groups to support the whole budget of the church. Our budget is not intended to be austere, but still we are always looking for ways to produce economy in building operation, maintenance and utilities.

We recognize our service to the congregation as a mission. When dealing with a building like OPC, parts of which are 125+ years old, we do sometimes get bogged down in details that would put the most alert person to sleep! Yes, there is always something to talk about, and decisions to be made (and money that needs to be spent); but we do try to remember why we are doing it, and for whom we are doing it.

Projects of Note:

- ◆ This year we had a special concern relating to the arrival of new pastoral leadership last spring. Our Interim Pastor, Dr. Drew Mann suggested (emphatically) that the Pastors' Office area, which also includes the Williamson Room were shabby and needed work. We realized that he was right, and that no major work had been done in those rooms since the office addition was completed around 1960! With the help of Session and the Finance committee, a special fund was established to pay for the renovations. We painted and installed new ceilings and upgraded lighting in both rooms, bought new furniture, sealed and insulated an unused outside door, and are in the process of installing interior storm windows.
- ◆ The beautiful stained glass in our Sanctuary was surveyed by experts, and many windows were found to need repairs and refurbishing. The "Christ in the Garden" window was near collapse even though it had been worked on in the 1990's. All were straightened and sealed, and structural repairs were done where needed. The firm we employed did very high quality work, and we are now in good shape. Regular surveys of window condition will be done in the coming years.
